- What are some myths and facts about speeding?



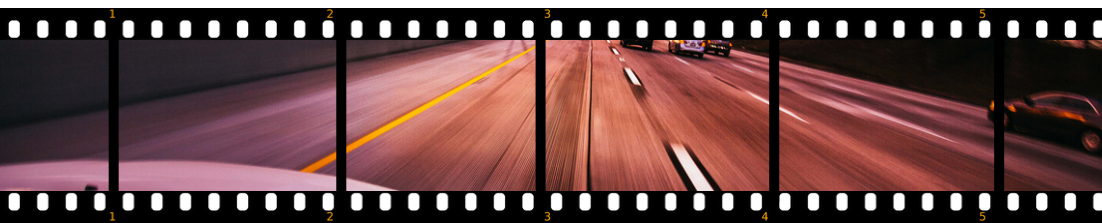
Contest Guidelines:

For your PSA videos:

Requirements include that your video must not include any footage of dangerous or reckless driving that is in violation of Delaware Vehicle Code or any Delaware law.

What are some examples that could get you DISQUALIFIED?

- The driver is holding a phone in his or her hand or using a phone in any way while the car is moving.
- The driver or any passengers do not have a seatbelt on while the car is moving.
- Being distracted while actually driving, such as putting on makeup, eating, or using a GPS.
- Being reckless while actually driving, such as speeding, swerving, or racing.
- The above list contains some **but not all** of the reckless and distracted driving choices that could get you disqualified. It does not matter if you are driving in the middle of nowhere, a parking lot, or very slowly while demonstrating reckless and distracted driving.

The video format must be MP4 and the maximum file size is 512 MB.

When your video submission is finished, email both the video and this completed application to Sarah.Cattie@Delaware.gov. Winning submissions may be used for educational purposed by the Delaware Office of Highway Safety, State Farm Insurance, and the Delaware Department of Education.
